

PRIVACY NOTICE
Science Now sp. z o.o.

This Privacy Notice is an information on processing your personal data by Science Now sp. z o.o. with regard to application and participation in the **Direction Earth/Space Creative Campus, Edition 2023**.

- (1) Pursuant to Regulation (EU) of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as: 'GDPR'), Science Now informs that:
1. the following entity is the controller of personal data of an Applicant: Science Now sp. z o.o. with its seat in Warsaw, ul. Wspólna 54A / 8, 00-684 Warsaw, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court for the capital city of Warsaw in Warsaw, 13th Commercial Division of the National Court Register under KRS number: 0000436005, NIP: 1132859300, REGON: 146313390, share capital : PLN 5,000.00;
 2. contact regarding personal data takes place by e-mail at the following address: office@sciencenow.studio
 3. an Applicant's personal data will be processed for the purpose of this applications – on the basis of Article 6 point 1 letter a of the GDPR (consent);
 4. an Applicant's personal data will be stored for 6 months or until the consent is withdrawn, unless the law requires a longer storage period;
 5. recipients of Applicant's personal data, depending on the need, will be entities authorised to obtain personal data on the basis of legal provisions and entities participating in the performance of the contract, entities providing legal services and security of personal data for the controller, providers of technical and IT services for the controller, European Space Agency;
 6. an Applicant has the right to request from the controller access to (as indicated in article 15 of the GDPR) and rectification (as indicated in article 16 of the GDPR) or erasure (as indicated in article 17 of the GDPR) of personal data or restriction of processing of your personal data (as indicated in article 18 of the GDPR), a right to data portability (as indicated in article 20 of the GDPR, should the processing be carried out by automated means), a right to withdraw your consent at any time (as indicated in article 7 paragraph 3 of the GDPR – the withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal);
 7. an Applicant has the right to lodge a complaint with a Polish supervisory authority – the Personal Data Protection Office (Urząd Ochrony Danych Osobowych, ul. Stawki 2, 00-193 Warszawa),
 8. the provision of personal data is voluntary, however refusing to provide the data may result in Science Now not being able to carry out the application process for the Applicant.

(2) Pursuant to GDPR, Science Now informs that:

1. the following entity is the controller of personal data of a Participant: Science Now sp. z o.o. with its seat in Warsaw, ul. Wspólna 54A / 8, 00-684 Warsaw, entered into the Register of Entrepreneurs of the National Court Register kept by the District Court for the capital city of Warsaw in Warsaw, 13th Commercial Division of the National Court Register under KRS number: 0000436005, NIP: 1132859300, REGON: 146313390, share capital : PLN 5,000.00,
2. contact with the controller regarding personal data takes place by e-mail at the following address: office@sciencenow.studio,
3. personal data of a Participant will be processed on the basis of:
 - Art. 6 sec. 1 lit. b and c of the GDPR in accordance with the Act of 23 April 1964 the Civil Code, the Act of February 4, 1994 on Copyright and Related Rights, the Act of September 29, 1994 on Accounting, the Act of March 11, 2004 on Tax on Goods and Services - in order to perform the contract or to take action at Participant's request, before concluding the contract and settling the contract in connection with the fulfilment of the legal obligation incumbent on the controller,
 - Art. 6 sec. 1 lit. f of the GDPR, as necessary for the purposes of the legitimate interests pursued by the controller in the form of establishing, investigating or defending claims in court, administrative or other out-of-court proceedings;
4. recipients of Participant's personal data, depending on the need, will be entities authorised to obtain personal data on the basis of legal provisions and:
 - based on Art. 6 sec. 1 lit. b and c of the GDPR and the above-mentioned acts - entities participating in the performance of the contract, entities providing legal services and security of personal data for the controller, providers of technical and IT services for the controller, European Space Agency;
 - based on Art. 6 sec. 1 lit. f of the GDPR: insurers, entities providing legal services and security of personal data for the controller, providers of technical and IT services for the controller, European Space Agency;
5. Participant's personal data will be processed:
 - based on Art. 6 sec. 1 lit. b and c of the GDPR and the above-mentioned acts - for the period necessary to ensure the proper performance of the contract and its settlement, taking into account the limitation periods for claims and tax obligations,
 - based on Art. 6 sec. 1 lit. f of the GDPR - until the legitimate interests pursued by the controller cease to exist;
6. a Participant has, depending on the above-mentioned basis of processing:
 - based on Art. 6 sec. 1 lit. b and c of the GDPR and the above-mentioned Acts - the right to request the controller to access personal data (pursuant to Article 15 of the GDPR), rectify them (pursuant to

Article 16 of the GDPR), delete (pursuant to Article 17 of the GDPR) or limit processing (pursuant to Article 17 of the GDPR) 18 GDPR), the right to transfer data (pursuant to Article 20 of the GDPR, when the processing is carried out in an automated manner),

- based on Art. 6 sec. 1 lit. f of the GDPR: the right to request the controller to access personal data (pursuant to Article 15 of the GDPR), rectify them (pursuant to Article 16 of the GDPR), delete (pursuant to Article 17 of the GDPR) or limit processing (pursuant to Article 18 GDPR), the right to object to processing (pursuant to Article 21 of the GDPR),
7. a Participant has the right to lodge a complaint with a Polish supervisory authority – the Personal Data Protection Office (Urząd Ochrony Danych Osobowych, ul. Stawki 2, 00-193 Warszawa),
 8. providing personal data is obligatory under the law, and in the remaining scope it is voluntary, however, refusal to provide data may result in the refusal or inability to become a Participant, that is to conclude the contract or to settle it, or the refusal or inability to take action at Participant's request before concluding the contract or inability to perform the activities for which it is necessary to process the Participant's data.
